CIRCULAR

Sub: Assessment of Second Year Courses under Autonomous Scheme

As per the 'Academic Regulations Governing the Degree of Undergraduate and Postgraduate Programs of VVCE-2020', the assessment details for Second Year courses of B.E. programme under Autonomous Scheme in the academic year 2021 -2022 is given below.

1. Continuous Comprehensive Evaluation (CCE): Students will be assessed for 50 Marks in all courses (Including Mandatory Non-credit Courses).

2. Semester End Examinations (SEE):

- (i) All credit courses will have SEE. 'Additional Mathematics I & II', a Mandatory Noncredit course will also have SEE. However, 'Constitution of India & Professional Ethics' course will not have SEE.
- (ii) SEE for all theory and laboratory courses including 'Additional Mathematics I & II' will be conducted for 100 marks in 3 hours duration and then reduced to 50 marks. However, in 'Universal Human Values', 'Skill Development -I & II' and 'Balake Kannada/Samskruthika Kannada' courses, the SEE will be conducted for 50 marks only in 2 hours duration.
