## ANNEXURE-9

NEW VVCE RESEARCH POLICY TO PROMOTE R&D ACTIVITIES VVCE encourages faculty members to involve in Research and Development activities continuously. To acknowledge their efforts in the R&D field, incentives / fee concession/ honorarium are paid for the following but not limited to:

- Registration fee, TA/DA, and incentives for paper publication
- Incentive for obtaining research funds
- 50% fee for membership in professional bodies
- Deputation for PhD with 50% pay
- Honorarium for consultancy work
- Tuition fee concession for in-house research scholars
- Incentive for publishing textbook
- Fee for filing patent
- Incentive for granted patent

### **1. PAPER PUBLICATION**

### a. Conference/seminar/workshop within India \*

- The institution shall bear the registration fee, TA / DA as per the AICTE/DST norms.
- A faculty member can avail this opportunity twice in an academic year.
- The ceiling limit is fixed @ Rs20,000/- per year.

### \* Only reputed institutions

### b. International Conference outside India

 Faculty member has to write well in advance to the funding agencies like AICTE, DST, CSIR, VTU etc. for seeking financial assistance. Usually, the funding agencies will reimburse the registration fee completely. In such a case, the institution shall bear only the TA and DA\*.

### The ceiling limit for TA and DA is:

Asian countries	Rs. 30,000/-	
Europe	Rs. 50,000/-	
USA	Rs. 80,000/-	

This opportunity can be availed once in 03 years.

\* In case, the faculty member gets TA and DA from funding agencies, he/she has to refund the amount to the institution.

Note: The application claiming incentive for publishing a paper shall be duly signed by all the authors affiliated to VVCE and shall be forwarded from the respective HOD.

## 2. Incentive for obtaining Research Funds:

For any research funds received, incentive @5% of the funds received from the external funding agency shall be given to the Investigators, i.e., 3% for the Principal Investigator and 2% for the Co-Investigators. Any other expenses such as incentives to any staff members, who assisted the Principal Investigator / Co-investigators shall be borne out of this 5% only.

### 3. Membership in professional bodies

 50% of membership fee of professional bodies will be paid by VVCE and it is limited to a maximum of Rs.10, 000/- per year.

### 4. Deputing faculty members for pursuing PhD in Institutions of National Importance

Eligible faculty members will be deputed to pursue PhD in Institutions of National importance such as IISc, IIT, NIT, IIIT and IIM for a period of 3 years with 50% pay.

### 5. Honorarium for Consultancy Work

The honorarium for consultancy work is as follows:

### 6. Tuition fee concession for in-house Research Scholars

Faculty members pursuing research in VVCE research centers shall be given 50% concession in tuition fee payable to the college

### 7. Publishing Textbook

An incentive of Rs. 10,000/- shall be provided to a faculty member publishing textbook with a valid ISBN.

### 8. Patent Filing\*

Entire fee for filing patent will be borne by VVCE as per VVCE IPR Policy

### 9. Incentive for granted patent\*:

An incentive of Rs. 20,000/- shall be provided to the chief inventor of a granted patent. Sharing of the incentive amongst the co-inventors can be done with a mutual agreement.

\* Filing of the patent shall be done through VVCE IPR Cell, and Vidyavardhaka College of Engineering shall be one of the Applicants.
