GUIDELINES FOR PAPER SUBMISSION

- Papers must be original and unpublished. They must not have been presented previously in any other seminars, conferences, etc. The paper should be between 15-20 pages (between 6,000 to 8,000 words including abstract, tables, figures, notes, references, etc) with half-a-page abstract.
- Font: Times New Roman, Format: 12 and 1½ spacing, and one inch margin in all four sides.
- Provide end notes, if necessary but not footnotes.
- Tables and Figures must be easily understandable and appropriate. Each table/figure must have a title/caption and they should be numbered continuously (Table - 1, Table - 2, etc., and Figure - 1, Figure - 2, etc).
- References throughout the text: (Authors name, year) in the parenthesis.

Details of references should be presented at the end of the paper:

- a. Journal Article: Author's Name. (Year of publication). Title of the Article. Title of the Journal. Volume (Issue): first and last page of Article.
 - b. Book: Author's Name. (Year of Publication). Title of the Book. Place of Publisher. Name of Publishing Company. p. or pp.
 - c. Unpublished Ph.D Thesis: Researcher/Author. (Year). Title of the Thesis. Thesis submitted to University. Place.
 - d. Online/Electronic Publication: Author's Name. (Year). Title of the Article. Journal Name. Volume (Issue): first and last page of Article. Web address and date of accessing/retrieving the material.
- Both Vidyavardhaka College of Engineering and the Department of Business Administration respect the rules in ethics of publication. Therefore, **authors are required to respect intellectual property and avoid plagiarism - authors are solely responsible for any plagiarism issues and/or legal consequences.**

Note: As the Department is planning to bring out an edited book with ISBN of quality papers, Delegates are requested to take maximum care to prepare high quality research papers.

Registration Fee and Payment Procedure: ₹ 750 per person (for Researchers: ₹ 500) which should be paid through Electronic Fund Transfer (EFT) to the College Bank Account. If the paper is considered for inclusion in the edited book and if the author wishes to include his/her paper in the book, then the authors are required to pay APC (article procession charge) of ₹ 1,000 per article (a copy of the book will be given at free of cost during conference).

The registration fee is inclusive of Conference kit, lunch and snacks and Certificate of Participation/Presentation (excluding accommodation). If the Delegates require, accommodation will be arranged at reasonable rates in nearby hotels but the room rent should be paid by the Delegates concerned
